ADI cannot determine the origin or legitimacy of products procured through brokers or other non-authorized sources. We cannot provide warranty coverage or any quality, reliability, failure analysis, applications, or other support on such products. ADI will neither accept returns nor provide credit on products that have been purchased from brokers or other non-authorized sources. Recent articles in semiconductor industry publications have reported the availability of used, damaged, and counterfeit products on the broker market. The leading reason that customers experience IC failures is because the products have been purchased from non-authorized sources. Non-authorized sources often sell products which may have been improperly handled/stored or may be counterfeits.

## **Question and Answer**

**Q:** Can I use the Analog Devices logo in my listing?

**A:** No, you cannot use Analog Devices intellectual property without our express, written permission. Unauthorized use of our logo would constitute trademark infringement under Section 32 of the Lanham Act,15 U.S.C. § 1114.

**Q:** Why was my listing removed?

**A:** ADI takes counterfeiting and protecting our intellectual property very seriously. Your eBay listing was most likely removed because 1) we have reason to know that the listing is an ADI counterfeit product or, 2) the listing infringes ADI intellectual property rights.

**Q:** Are ADI products sold on eBay covered under ADI warranty?

A: No, products sold and purchased on eBay are not covered under ADI warranty.

**Q:** Can I use the ADI logo with a disclaimer?

**A:** No. Disclaimers do not negate trademark infringement. For example, if you use the ADI logo and write, "ABC Company is not an authorized distributor or representative of the products featured on this website. All product names, trademarks, brands, and logos used are property of Analog Devices, Inc.," this still does not give you the right to use the ADI logo.
