## **FAQ**

- 1. Why was my listing removed?
- a. Please contact authenticity@babyfoot.com
- 2. Why did eBay allow me to post my listing if it violates intellectual property laws?
- a. eBay does not pre-screen auctions.
- b. It is Baby Foot's responsibility to enforce its intellectual property rights.
- 3. How did Baby Foot determine that the product(s) I'm selling is counterfeit and/or infringing intellectual property rights?
- a. Baby Foot makes the determination after reviewing the images provided in the auction and/or purchasing a sample product for review.
- b. Baby Foot does not disclose the characteristics of counterfeit goods and ways to identify them. If disclosed, counterfeiters will be able to create more fraudulent goods.
- 4. Can I sell Baby Foot branded products even though I am not sure if they are genuine ornot?
- a. Innocent intent does not negate liability under state and/or federal trademark laws, the sale of infringing products is **ILLEGAL** and the seller takes full responsibility of his or her action. Baby Foot USA is the only authorized importer of Baby Foot products in the U.S. from Japan.
- 5. Can I use Baby Foot branded logos or properties owned by Baby Foot to promote my eBay listing?
- a. No.
- b. However, the texts, images, logos, and videos that appear on Baby Foot's website, social media pages, online and magazine promotions and printed product literature are Baby Foot's intellectual property and protected under state and/or federal laws.
- 6. Can I list an item and claim it is "NOT GENUINE", "NOT AUTHENTIC" or similar words?
- a. No. No matter how you phrase the product, it is illegal to sell counterfeit goods.
- 8. If I purchase a genuine Baby Foot product, can I re-sell it on eBay?
- a. Yes. It is legal to re-sell a genuine item that you purchased. Also, you may have limited rights to describe the item using its product name and/or Baby Foot's trademark, subject to the limitations set forth in Paragraphs 5 and 9.

- 3. Every box is labeled with a unique serialized 2-D Bar Code at a significant expense. If the Baby Foot product doesn't have an "Authenticity Code" on the bottom of the box (shown below), it is not a genuine Baby Foot product.
