FAQs

Why was my listing removed?

Why did eBay allow me to list my auction if it violates Intellectual Property Infringement?

Why didn't you contact me directly before removing my listing?

Given the breadth and scope of products from PPG and its affiliates, it is prohibitively costly for us to contact every owner of every listing. eBay is responsible for the listings posted on its website and so we go through them.

What if I inadvertently infringed upon PPG's intellectual property rights and did not realize?

How can I verify that I'm purchasing a legitimate PPG product on eBay?

PPG will not compensate any person who purchases a counterfeit product from an eBay seller, nor one who relies upon any performance claims of the same.
