As an eBay VeRO Program member, Royal Silk reviews items for sale on eBay regularly. We take great pride in the quality and workmanship of the products we produce and the warranties provided with those products. Royal Silk will use eBay's VeRO program to report the listing(s) of any auctions it considers infringes its rights in any territory in which product is offered for sale or delivery. Royal Silk cannot assist in the reinstatement of any auctions or eBay accounts which have been terminated by eBay following a legitimate request by Royal Silk in any territory.

Royal Silk works to ensure that all unauthorized uses of its intellectual property are removed from eBay. When an auction listing that improperly uses Royal Silk trademarks and/or copyrights comes to its attention, Royal Silk reviews the matter and takes appropriate action.
