Q: Why did my auction get shut down?

A: Most likely, your auction was shut down because it displayed unauthorized reproductions of copyrighted images or trademarks owned by Wax Liquidizer

Q: What if I did not know I was infringing on Wax Liquidizer intellectual property rights?

A: You have a responsibility to ensure your actions do not violate someone else's intellectual property rights. Innocent intent does not negate liability under state and federal copyright and trademark law.
